Bus a Potenza Trotta riassume 5 lavoratori ex Cotrab

■ Finisce nel migliore dei modi la vertenza per cinque lavoratori ex Cotrab che entrano nell'organico del nuovo gestore del trasporto pubblico di Potenza, Trotta. A seguito di un ricorso con richiesta di provvedimento d'urgenza, i cinque lavoratori, difesi dall'avvocato Giampaolo Brienza, legale della Faisa **Cisal**, hanno raggiunto un accordo che riconosce loro il diritto alla riassunzione con anzianità come dalla prima sentenza di reintegro sul posto di lavoro già a far data dal primo maggio 2016 con contratto a tempo indeterminato. I cinque, lo ricordiamo, erano stati licenziati da Cotrab, ma il giudice del lavoro aveva sentenziato per la trasformazione del rapporto di lavoro da tempo determinato a tempo indeterminato. Riassunti per soli due giorni dalla stessa Cotrab, i cinque lavoratori non si erano visti riassumere da Trotta. Di qui il nuovo braccio di ferro. Il segretario regionale della **Faisa-Cisal**, Donato Colangelo: «Si è conclusa una tormentata vicenda che metteva a rischio el famiglie dei lavoratori, sebbene sulla vicenda si sia registrato il generale silenzio e lo scetticismo da parte di tutti coloro deputati alla salvaguardia dei diritti e della dignità dei lavoratori».
