Quello del prossimo 2 febbraio sarà un altro venerdì nero per il trasporto pubblico locale su gomma. Dopo quello dello scorso 12 gennaio, i sindacati Filt-Cgil, Fit-Cisl, Uilt-Uil, **Faisa-Cisal** hanno indetto un nuovo sciopero del personale della Ctt Nord impiegato a Pisa e provincia. Uno stop di quattro ore (dalle 11.59 alle 15.59) per contestare ancora una volta «i

problemi e i disagi causati agli autisti dall'introduzione della "monetica"», il nuovo sistema di bigliettazione elettronica avviato a Pisa lo scorso giugno. I rappresentanti dei lavoratori contestano in particolare la mancata concertazione nella fase di introduzione del nuovo sistema di vendita dei titoli di viaggio a bordo degli autobus. Uno dei principali problemi sarebbe rappresentato dalla distanza tra la cabina guida e

le "consolle" per la stampa dei biglietti installati sui bus che costringe spesso l'autista a lasciare momentaneamente il posto di guida per emettere il titolo di viaggio. Motivo che per i sindacati è anche alla base dell'aumento dei ritardi delle corse dei bus. Le organizzazioni dei lavoratori rivendicano inoltre l'incremento della percentuale a favore degli autisti sui ticket emessi a bordo. (d.r.)

Contraddizioni palpabili nel comparto sanitario. Da un lato, si utilizza l'argomento delle carenze d'organico per giustificare disservizi e continue richieste di personale; dall'altro, però, i dipendenti che potrebbero essere utilmente impiegati nelle corsie d'ospedale o nei presidi delle aziende per fornire rapide ed efficaci risposte alla vasta domanda sanitaria che attraversa i territori subiscono inusuali dirottamenti verso uffici e mansioni diverse da quelle per cui sono stati assunti.

Non si vogliono certo condannare le pur legittime aspirazioni di crescita professionale ma semplicemente rilevare una stortura che conduce a sguarnire le avanguardie sanitarie per ingrossare le fila di una categoria amministrativa che ha il suo centro gravitazionale nel dipartimento regionale Tutela della Salute.

I trasferimenti dalle corsie degli ospedali agli uffici delle stesse aziende sono, infat-

ti, solo la punta dell'iceberg di un fenomeno ben più esteso che ha fatto incetta di profili professionali sanitari attraendoli verso le scrivanie della cittadella regionale. Si inizia da un provvedimento di utilizzo temporaneo, solo qualche mese o qualche anno, in cui il dipendente viene provvisoriamente trasferito e "comandato" a ricoprire un incarico diverso al dipartimento regionale per passare poi attraverso progressivi rinnovi che di fatto segnano una strada di non ritorno dalle aziende di provenienza.

Dirigenti medici, infermieri professionali, ostetriche, nutrizionisti, psichiatri, cardiologi. La lista è lunga almeno quanto le risorse drenate alle aziende sanitarie che spesso, soprattutto durante la stagione estiva, sono costrette a interrompere o ridurre la quantità di prestazioni erogate per l'assenza di profili professionali adeguati. La diaspora va avanti da anni allo scopo di

rimpiangere il personale in forza al dipartimento Tutela della Salute sceso inesorabilmente sotto l'asticella degli standard minimi ma l'effetto è dirompente per le aziende costrette a cedere preziose unità di personale e di conseguenza, a centellinare le prestazioni in base all'organico disponibile.

L'Azienda sanitaria provinciale e l'ospedale Pugliese sono le due strutture più propense a rinunciare ai propri dipendenti seppur gravate dalle più onerose responsabilità d'erogazione di cure mediche sul territorio. Sebbene la maggior parte dei trasferimenti interessi profili professionali amministrativi che quindi abbandonano le postazioni aziendali per portarsi al dipartimento regionale per svolgere analoghe funzioni, non manca però personale con specializzazioni squisitamente sanitarie e tecniche impiegate nei medesimi ruoli.

Vi sono casi, ad esempio, di infermieri professionali

provenienti dall'Asp e che hanno trovato posto negli uffici del dipartimento ma anche uno psichiatra che inizialmente svolgeva la propria funzione al dipartimento Tutela della Salute Mentale dell'azienda sanitaria, anch'esso "comandato" alla Regione. Vi è, ancora, un tecnico ex dipendente del dipartimento Prevenzione ceduto dall'Asp alla cittadella ma anche un buon numero di dirigenti medici che adesso, smesso il camice, hanno assunto funzioni dirigenziali.

Poco o nulla ha invece rinunciato il policlinico universitario Mater Domini. Risultano infatti trasferimenti di soli dipendenti amministrativi e in numero davvero limitato. Il caso delle "cessioni" dalle aziende al dipartimento di impiegati era stato sollevato qualche tempo fa dal sindacato **Cisal** che aveva puntato il dito contro il mancato utilizzo di personale amministrativo interno all'ente e l'abbondante ricorso, invece, all'esterno per colmare i vuoti d'organico. ◀

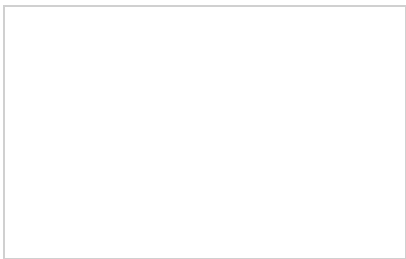

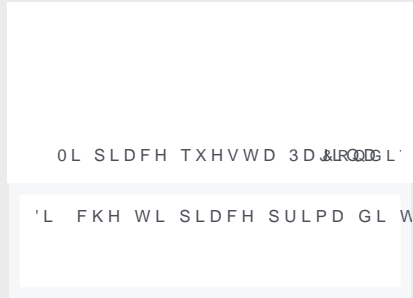
